
Photographs of the award winning properties will be on display at Tower Square through June.

Carriage House Tour



She enjoys being a house captain on the house tours, working at the Mattoon St. Festival, and helps the board by keeping a list of monthly tasks. She is the person who answers the emails sent to the trust via the web site. She has always had an interest and love for older homes/buildings. She has been a board member of the East Forest Park Civic Association for the past six years and a member since 1993.

Don Courtemanche – is the Executive Director for the Springfield Business Improvement District and has been on the SPT board for 3 years. He has a strong belief that historic preservation enhances our community. He is a member of the International Downtown Association, Greater New Britain Arts Alliance, and the New Britain Historical Society.

Dr. Robert Holbrook – a retired Dentist who resides in Springfield, he has been on the SPT board for the past 9 years. The Preservation Trust is just one of the many boards he belongs to: The Kimball Tower Condominium Board, The Armoury-Quadrangle Civic Association, The Springfield Museum, The Springfield Exchange Club and The Pioneer Valley Dental Society all bide for his attention and dedication. TRUST RECEIVES \$50,000 GRANT FROM MHC

Just as the newsletter is going to print, we have received wonderful news that the Massachusetts Historical Commission has awarded fifty thousand dollars for exterior renovations to 77 Maple Street from the Massachusetts Preservation Projects Fund. This fund requires a local match, and SPT will be able to use the fifty thousand dollars received in January from The

1772 Foundation. Our architect, Bill Devlin, will be preparing construction documents for this \$100,000 project which will address both north and south elevations of the building. Work will start in autumn.

The Trust would also like to thank Matt Crouse, of Crouse Landscaping LLC, for volunteering to mow the lawn at 77 Maple Street.
