Casino Update



On April 1, 2014, the Masachusetts Gaming Commission held a host community meeting at the MassMutual Center. After MGM made its presentation; many of those in attendance had the opportunity to express their support or concerns. Both Jim Boone and Bob McCarroll spoke of the historical significance of the buildings in the MGM casino footprint and asked the commission to consider saving more of these historical properties. Following this meeting the SPT Board of Directors voted to send the following letter to the Gaming Commission:

Dear Commissioners:

The board of directors has voted to write regarding the current MGM casino plan and the damage it will do to historic buildings in Springfield.

Our members attended the three presentations by MGM to the Springfield Historical Commission (SHC) regarding the 14 historic resources on the development site.

In January 2013, MGM proposed to reuse the former MassMutual Building at 1200 Main Street, to move and reuse the former Spiritualist Church on Bliss Street, to retain the front half of the Armory on Howard Street as a restaurant, and to incorporate the façade of the United Electric Building at 73 State Street into its hotel. Everything else would be demolished.

In April 2013, the SHC asked MGM to reuse the Union House at 1132-1143 Main Street; to incorporate facades of 79 & 95 State Street, Edisonian Building, and YWCA; to reuse the rear portion of the Armory; and to reuse the elaborate lobby of 73 State Street.

In January 2014, MGM had not change its plans but spent the meeting justifying why historic resources couldn't be reused—one façade was too tall, one too short, one too off-center, and one with a floor height too high. Yet, the façade of 73 State Street will be incorporated into the hotel. Despite being shorter and having a different floor height. Regarding Union House, MGM claimed that they wanted a large service basement under the complex and retaining Union House would be in the way. Local architects have told us that that issue can be solved.

At Tuesday's presentation to the MGC, MGM still had not changed its plans regarding the number of historic resources that would disappear forever.

Our members noted the lackluster response by Michael Mathis when questioned by Commissioner Crosby on saving additional historic resources.

We feel that MGM has not seriously looked at including more historic resources in their proposal. The board is especially concerned about the 1846 Union House, the oldest and most historic building in the project, and the YWCA, the most architecturally important building. The four-story Union House sits where MGM is proposing four-story new buildings. The YWCA façade sits where the southern casino wall will be.

We urge you to vet the design plan and its impact on the historic resources of Springfield as diligently as you have vetted the gaming companies themselves. We urge you to make incorporating more historic resources as a condition of the MGM license. Loss of our historic buildings should not be the cost of MGM coming to our city.

After outgoing President Ben Murphy welcomed everyone to the meeting,




Bob McCarroll gave a tribute to Dr Robert Holbrook. Robert was a great supporter of the trust and his death a great loss to the preservation community.

Ben highlighted the events and activities of the past year, reviewed some of our upcoming events, and shared the progress on 77 Maple St. Newly elected President, Don Courtemanche, presented the 2014 list of endangered properties (see following article) and introduced guest speaker, James Woolsley, Superintendent of the Springfield Armory National Historic Site.



Superintendent Woolsey shared the history of the site which was created to manufacture weapons. Unfortunately, the closing of the Armory had a significant economic impact on the city. He also discussed plans to to restore the gardens and the surrounding landscape, and is looking for a tenant for the

Commandants House to help with renovating the property.

Neil A. Daboul, Merchant Marine Captain/Philanthropist

Born and raised in Springfield, Neil recently returned to the area after 32 years service as a Navy and Merchant Marine Officer. She has always been a strong supporter of preserving historic properties and has lived in 3 different Springfield Historic Districts.

Gavin Gardner

Gavin works at Springfield Armory National Historic Site as the Resources Program and Facilities Manager. Gavin recently moved to the area from New Mexico where he worked to protect and preserve 17th century Spanish Missions at Salinas Pueblo Missions National Monument. Originally from Maryland, Gavin headed west for college in Arizona. An archeologist by trade, he has worked for the National Park Service at a variety of parks throughout the country including Yosemite, Death Valley, Point Reyes National Seashore, Tonto National Monument, and Klondike Gold Rush National Historical This is his first time living in the east since leaving for college and he is excited for the change. He is a new member to SPT and was asked to join the board as a representative of Springfield Armory.

2014 Most Endangered List

This past year a committee was formed to address the issue of endangered properties. Led by board member Timothy Cummings, a database of properties was created and for the first time, opened nominations to the public. There were 30 nominations, 6 from the community; the following 11 properties were selected.

77 Maple Update

Although not much is visible yet, work is proceeding well with 77's trim and window work. The scope of trim in this phase includes the 2 ends of the Main Building, the rear end of the Main Ell, and most of the trim around the North Ell.

Most of the windows being done are those that are "safe" from anticipated Design impact. This means that some windows in the rear will be impacted when a new addition is added to replace the badly-deteriorated wood-framed ell. The few remaining "safe" windows are in the Main Ell's south side.

The long, harsh Winter has delayed much of the exterior work; the timeframe to complete the project is somewhat tight with a deadline next month. A meeting of SPT's Architect and the GC will be held soon to coordinate on the schedule for completion.

Work done includes:

- Window frames and sash have been de-leaded, down to bare-naked wood
- Window sash have been re-glazed, painted, etc., in a heated shop
- Framing details for exterior trim have been worked-out w/ General Contractor (GC)
- Window-rebuilding details have been resolved
- Some exterior work has been started
