The meeting ended with a guest speaker Catherine Ratte of the Pioneer Valley Planning Commission discussing Springfield's Neighborhood Investment Plans. The environmental assessment is complete. No surprise, there is some asbestos which needs to be removed. Crack monitors have been installed to determine if the visible settlement continues or has stopped. ### HISTORIC HOMES TOUR: QUADRANGLE-MATTOON STREET HISTORIC DISTRICT

The Springfield Preservation Trust's Historic Home Tour and social is back for 2024. It will take place in the Ouadrangle-Mattoon Street Historic District. This is the oldest local historic district in Springfield, MA. The social this year will take place at Springfield Museums on June 2nd. #### HISTORY OF THE HOME AND ITS ORIGINAL OWNERS

These two adjoining houses at 50 (left) and 52 (right) Mattoon Street in Springfield were built around 1872-1873, and they were among the first of the Victorian-era townhouses to be built here on Mattoon Street. These early houses tend to have the finest architecture, as the Panic of 1873 - and subsequent economic recession – curtailed development on the street and led to less expensive, less ornate houses during the later 1870s.

The house in the foreground, at 52 Mattoon Street, was originally the home of furniture dealer Julius A. Eldridge and his wife Catherine. However, they were evidently not here for very long, because by 1880 it was owned by Henry W. Chapin, a patent solicitor of the firm of Chapin & Co. That year's census shows him living here with his wife Sarah, along with three daughters and a son, William, who worked for his father's company. The census also indicates that their neighbor at 50 Mattoon Street was Charles P. Lyman, a veterinary surgeon who lived here with his wife Mary, three young children, and two servants.

The large townhouses on Mattoon Street had been built as single-family homes, and were generally used as such for the first few decades. However, this began to change by the turn of the 20th century, as the street became more middle class. Both 50 and 52 Mattoon were still single-family homes at this point, but many of the neighboring ones had already been converted into rooming houses. The 1900 census shows Horace Eddy renting 52 Mattoon, where he lived with his wife Martha, their son Arthur, and Arthur's wife Florence and son Lawrence. Their neighbor at 50 Mattoon was Thomas Keating, an Irish-born machinist for Gilbert & Barker, and he lived here with his wife Margaret and their three children.


By the time the photo was taken in the late 1930s, many of the houses on the street had become rooming houses, including both of these properties. The 1940 census shows that 52 Mattoon was rented by Alice LeBlanc, who in turn rented rooms to 11 lodgers here. At the same time, 50 Mattoon was owned by Lester Hammond, a city policeman whose wife Fannie was listed as a rooming house proprietor. There were only two lodgers staying here during the census, although they likely would have had room for many more, as indicated by the number of people living next door.

# **JOHN BELLOWS REMEMBERED AS AN ACTIVE PRESERVATIONIST & ADVOCATE**



John stepped up in the 1970s as a part of the few Springfield residents who reconstituted the Trust after its founding in 1972 and short-lived first run. He served as the Treasurer starting in 1979 and well into the 1980s, and on the Board of Directors most recently, until early 2023.

As an advocate for Springfield, he was an ambassador for the Springfield Preservation Trust and all that we do. He served on he board two different times and until recently," Past President and current Board Member Jim Boone says. As fellow real estate agents, John and Jim shared a passion for not only living in, but selling historic homes.

John was an active preservationist, Jim says: "John loved old houses and lived in wonderful ones on Florida St, Riverview St, Washington Rd, and Bonnyview St in Springfield and Forest Glen Rd, Lincoln St, and Longmeadow St in Longmeadow."

Bill Malloy, current member and former board member from 1978 to 2002, recalls that John saw the days in the 1970s when the Trust held board meetings at 7-9 Stockbridge Street-which the Trust now owns and is rehabilitating-when the building was under the ownership of architect Peter Zorzi. We know that John's spirit will live on at Stockbridge as we make the Trust's new home there.

"John supported all the activities of the Trust," Bill adds. "His positive energy and delightful personality was appreciated by all those that became close friends."

As we send John's spirit to rest, we leave our membership with the final words of John's December 24, 2022 letter to the Board to decline reinstatement as a Board Director: "It has been a great privilege to have been involved with the Trust from its early days to the present time. What a journey it has been. The Trust has matured from a little known group of a few concerned Springfield residents to a well run organization; recognized by many and greatly effective in shaping city policy and opinions towards preservation."
